### Level 3+ Approved Flex list



#### Introduction and purpose

- 1. It is key that we build the right skills in our workforce to deliver improved productivity and prosperity enabling all groups to access jobs. Whilst qualifications levels are improving, significant shortfalls remain at level 3+ impacting productivity, competitiveness and inward investment which hold back the growth of the regional economy. In addition, low skills also impact earnings and household income for residents in securing sustainable employment in higher-skilled job roles.
- 2. In 2021/22 we will continue testing partial or full funding of some Level 3+ qualifications where they support progression in work and/or career changes.
- 3. During 2019/20, WMCA introduced funding flexibilities to test the impact of partly or fully subsidising level 3 qualifications, in key sectors, to encourage more individuals to access this provision.

#### The offer


- 4. The below list covers flexibilities previously agreed with WMCA grant providers. WMCA would now like to extend the offer to all grant providers as listed below.
  - 4.1. Contract for service providers (ITP) will need to follow the business case process if they wish to add any of the below added to their delivery plans.
- 5. The level 3+ flex will be fully funded where they meet the below situations, where they support WMCA priorities related to the movement of residents into work or upskilling those in low pay jobs
  - 5.1. Those who do not meet the first full Level 3 (National policy legal entitlement) where they are unemployed/low wage i.e. 2nd level 3 and/or the qualification is not listed on either the legal entailment or NSF list
  - 5.2. Those taking their first full level 4/5 where they are unemployed/low wage
- 6. If you are seeking to extend these to none low wage employed this will need prior approval through a business case with clear intent and need.

#### Approved for all Grant providers 2021/22

- 7. The qualifications in **Table 1** can be delivered without prior approval by Grant providers. Qualifications are only agreed as certificate or diploma level the only exception to this is where awards are highlighted below.
  - 7.1. Additional awards will need prior sign off by WMCA.
- 8. WMCA has shown the example LARS code below, however, please note, providers can choose the awarding body of their choice.
